#### **Introduction**

Thank you for your interest in doing business with Okaloosa Gas District. These guidelines are provided to assist you with following our requirements in order to do business with us.

# **Our Mission**

Okaloosa Gas District is an independent Special District authorized by the legislature of Florida using Chapter 2000-433 (House Bill 1637). The District was originally established in 1953 and is charged with the mission to support the natural gas distribution needs of the communities within our 450 square mile service territory. Our mission is to safely deliver natural gas service to over 41,000 residential and commercial customers (4.9% of the natural gas customers in Florida). We sustain over 1,200 miles of natural gas pipeline with over 150 dedicated employees. Our annual budget is approximately \$30M.

# **Vendor Registration**

Vendors desiring to do business with Okaloosa Gas District must register on the Florida Purchasing Group website at http://www.BidNetDirect.com/florida

Once you are registered, you will have access to solicitations posted by the District and our peer governmental entities. It is the vendor's responsibility to keep their information current on this site.

our limited staff, we cannot support walk-in business visits.

Okaloosa Gas District is exempt from taxes imposed by the State or Federal Government. During business transactions, we will furnish the exemption certificates authorized by Florida Statute, Chapter 212.

# **Documentation Prior to Payment**

During the initial business transaction, we also require a vendor registration form and a W-9 to be sent to the District prior to payment for goods or services rendered.

#### **Vendor Qualifications**

Safety is a major concern within the natural gas distribution and transmission industry. Our natural gas pipeline construction requirements drive the need for vendors to be compliant with the Department of Transportation's (DOT) Pipeline and Hazardous Materials Safety Administration's (PHMSA) Operator Qualification (OQ) program. This program is defined in 49 CFR 192. There are multiple requirements for this type of contracted work

dealing with formal task qualification for workers, formal record keeping, and welding tests along with an active drug-testing program. Construction vendors must carry the proper licenses to support the type of work required. Contractor drug testing reports to PHMSA must be combined with the District's.

If the construction work involves any of the infrastructure dealing with natural gas distribution to customers the District will require safety and qualification training of the vendor. Our training staff and our Safety Director will arrange for this training to be accomplished.

On the job site, our Safety staff must be allowed to examine the work in progress to validate specifications and quality of work.

# **Insurance Requirements**

All vendors are required of Governmental Purchasing (NIGP to submit current Certificates of Insurance for liability and worker's compensation or worker's compensation exemption certificates before any work commences for the District.

# **Ethics**

Employees of the Purchasing Division of Okaloosa Gas District abide by the Code of Ethics of the National Institute) and are members of the Gulf Coast Chapter of NIGP. The acceptance of gifts or gratuities of any kind by the purchasing staff is prohibited by the State of Florida under Florida Statute 112.313(2) and Okaloosa Gas District Policy.

#### **Minority/Women Businesses**

Okaloosa Gas District encourages all segments of the business community to participate in its purchasing program.

#### **Requirement Advertisement**

Under the guidelines for Florida Special Districts new construction projects must be formally competed. Based on the value of a purchase we use verbal and written requests for quotes up to a threshold of \$25,000. Look for our formal solicitations above \$25,000 to be posted on the Florida Purchasing Group, <a href="https://www.floridabidsystem.com">www.floridabidsystem.com</a>, with construction requirements advertised in the legal section of the Northwest Florida Daily News or Pensacola News Journal.

The new PHSMA Distribution Integrity Management Program (DIMP) will drive multiple new capital projects for the District over the next 5-10 years.

# **State of Florida Term Contracts**

The District uses numerous term contracts published by the State of Florida Department of Management Services. We encourage vendors to participate in these contract arrangements. If you are involved in a contract where "piggy back" arrangements are allowed please point this out to the purchasing official.


